### Responsibilities

- Intimate the deviations from this plan and other accepted procedures to the project Manager for his necessary corrective and/or preventive action.
- I will monitor the site activities on a regular basis and will advise and assist all personnel at the site on the Implementation of SH&E plan and compliance with the relevant SH&E legislation.

- Plan the requirement of first aid, firefighting and safety appliances in coordination with the site execution team

- Organizing HSE meeting once in a month, which will be chaired by the GM and maintaining the minutes of the meetings, arranging Induction programs for all the staff and workmen on their arrival at the site and organizing refresh sessions whenever required. Records of such programs shall be maintained at the site offices.
- Conducting risk assessment for major works, based on the method statement provided by the execution team before they are taken up to identify the possible hazards and the precaution to be taken.
- Organize and/or conduct SH&E training for all project personnel.

- Provide training on toolbox talks to the supervisors working under them and pass the records to the SH&E department on weekly basis.
- Identify weakness and deficiencies in job procedures and rectify those If possible, refer those to General Manager.
- Make random spot checks of tools and equipment used by the workmen and takes measures to rectify unsafe condition.
- Give SH&E Instruction to workmen on daily basis as a part of the relevant requirements, highlighting the possible hazards of the days work and the precautions to be taken.
- Plan and arrange for critical activities before they are undertaken and inform the relevant department head and the SH&E representative about the task well in advance.
- Prepare method statements for all the critical activities in prescribed formats ,In liaison with the General Manager and execute the measures suggested by him .
- Ensure that the operatives working are issued necessary PPE and they used the same.
- Promote the continuous Improvements of SH&E performance.
- Verify the third party test certificates while lifting appliances for their validity.
