- ? Identify and test work areas for potential accident and health hazards, such as toxic fumes and explosive gas-air mixtures, as well as implement appropriate control measures.
- ? To insure good house keeping, check all stair ways, passage ways and gang ways keep free from materials and obstruction of any kind should be removed.
- ? To promote & maintain fire safety standard, uses of fire extinguishers.
- ? To insure safety precautions for handling electricity & positive isolation.
