Regularly evaluate safety and health performance to improve procedures and policies. Oversee implementation of operational systems and procedures to include but not be limited to: Permit to Work System, Lock-Out/Tag-Out System, Hazardous Chemical -MSDS, PPE System, HLO, H2S Awareness, Benchmarking, NOWA and other required training activities . Ensure that all workers use the appropriate personal protective equipment. Provide training on the proper use and maintenance of personal protective equipment. Ensure that service companies comply with safety and health procedures . Provide guidelines and instructions to service companies on the safety procedures followed on location. Maintenance of the Corrective Action Register for non-compliance items arising from meetings and inspections. & During Rig Move: Conduct daily Pre-Rig or Rig Move daily meeting with Offset operators and drivers. Review the PTW for the major jobs such as lower or raising mast and rig floor, disconnect, lowering & raising TDS & reconnection of flare line and all critical lift plans. Conduct inspection of the roads of the new location as part of the team identifying the blind spots (taking pictures as necessary) - to be uploaded to quest .
