Responsible for ensuring the manifest documentation is raised for customs clearance, transportation and consignee's identification. ? Receive and deliver equipment, including client equipment if required. ? Ensure store areas are well maintained. ? Ensure all requisitions are correctly coded. ? Ensure consumables are ordered on a quarterly basis, stock-checked and have an up-to- date balance onboard. ? Ensure a log is kept of all active rental equipment. ? Ensure Stores procedures are followed for returns from Rig, and a tracking log in place for all equipment being returned for Repair/Credit etc. ? Ensure all waste movements are properly manifested, packed and segregated according to procedure. ? Any other duties as required by the HOD's.
